## CITY OF CLARKSDALE CLARKSDALE, MISSOURI WATER USERS' AGREEMENT- 10-30-2018

The undersigned, being the owner or occupier of land located within the City of Clarksdale, hereby makes application to said Municipality for **one** water service connection, and if water service is made available by said Municipality, agrees to the following conditions:

1. Pay a minimum monthly meter charge of \$\_\_53.00\_\_ per month for 1,000 gallons of water and sewer service from the time service is made available by the Municipality, and pay for additional water used at the rate set out in the rate schedule adopted by the City Council. Any changes made in the minimum monthly water charge and rate schedule by the City Council shall become a part of this agreement as though fully set out herein.

2. Pay a water user's deposit in the amount of **\$150.00** for all owners, and **\$250.00** for all renters. This water user's deposit shall be kept on account with the City of Clarksdale until such water user, owner or renter shall move from the city. At such time the deposit will be refunded minus any balance owed.

3. The Ordinances of the Municipality provide that the Municipality will read the water meters, the undersigned agrees to pay said service bill on or before the due date indicated on the billing statement, or be subject to a **late charge of 5%**. Failure of the Municipality to submit a service bill shall not excuse the undersigned from his obligation to pay for the water used when the bill is submitted. Failure to pay a bill by the date indicated on the late notice shall result in a late fee, and subsequent disconnection.

4. The water service supplied by the Municipality shall be for the sole use of the undersigned; the undersigned agrees that he will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, nor will he share, resell, or submeter water to any other consumer. Each meter service shall supply water to only one residence or business establishment located on land within the District.

5. If after water service is made available the same is discontinued or disconnected for any purpose, pursuant to the Ordinances of the City of Clarksdale and the Policies of the Clarksdale Water Department, a \$50 reconnection fee shall be assessed, and reconnection shall be upon the conditions set out by those Ordinances and Policies.

6. The undersigned agrees that he will make no physical connection between any private water system and the water system of the Municipality. Representatives of the Municipality may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision. Violation of this provision shall be grounds for disconnection of service.

7. The laws of the State of Missouri, the ordinances of the City of Clarksdale and Policies of the Clarksdale Water Department as presently existing, and as may be amended from time to time, are made a part of this agreement as though fully set out herein.
